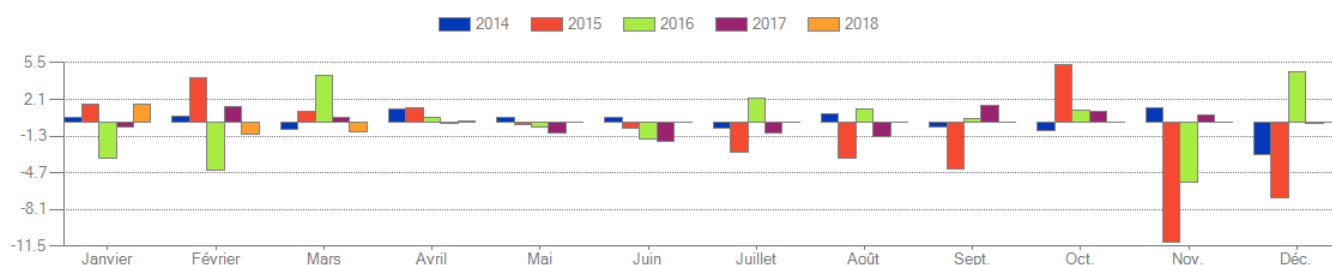

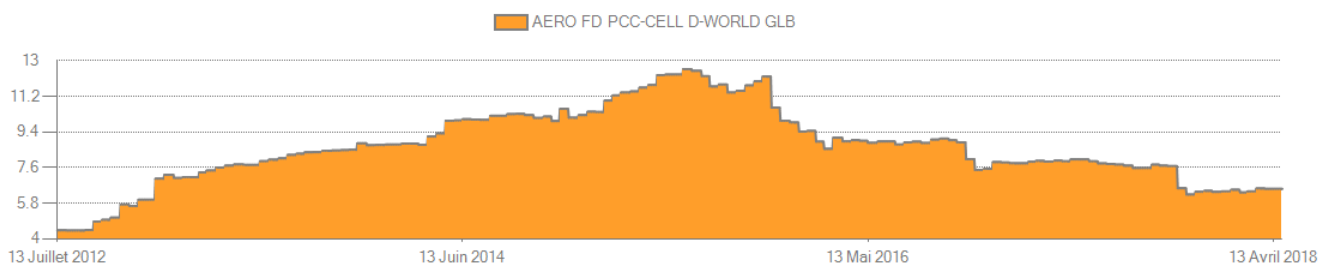

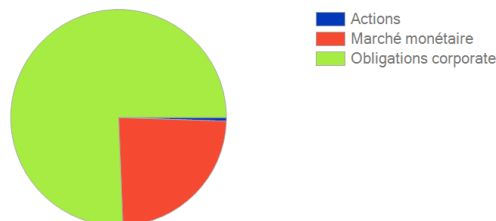

as of 03/31/2018

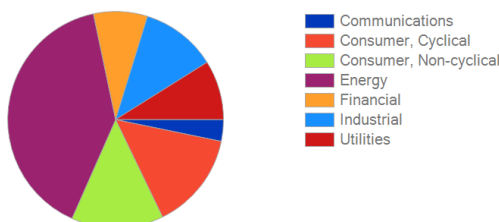

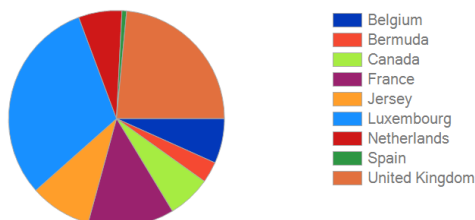
